This qualitative study offers a detailed analysis of the opinions, attitudes, and feelings of seasoned journalists from prestigious newspapers and TV networks around Pakistan through semi-structured interviews. Eleven journalists all with at least ten years of experience were having talks at their homes or places of employment, and the questions were sent out by email beforehand. The research reveals a difference in media coverage based on affiliation with or opposition to the government, when the gatekeeping hypothesis is applied to the study's findings. Media organizations that supported the press thrived financially and professionally, while those viewed as being against the press were subject to heightened scrutiny and punitive actions. Online harassment of journalists was further exacerbated by the proliferation of troll farms with ties to the government. The study's observation that authoritarian and democratic countries use similar strategies to control the media is intriguing. An in-depth examination of the complex relationship between Imran Khan and the media, as interpreted by the Gatekeeping Theory of Communication Studies, is necessary in order to fully comprehend the media's impact on the evolution of society. Although the piece acknowledges President Musharraf's beneficial contributions to media freedom, it also emphasizes how social media has become the dominant force in modern times, giving everyone access to the world. This study adds to the growing body of knowledge about how important the media is in forming societies and assisting in the difficult process of democratic government.

# 1.1 Background

In the past, the government in Pakistan strictly managed and regulated the media. Media censorship was prevalent throughout the country's military regime, and several newspapers were shut down or banned for publishing articles that were critical of the government's policies. Press freedom in Pakistan has faced several difficulties throughout its complicated history. Pakistan is one of the most dangerous countries for journalists, according to a report by the Committee to Protect Journalists (CPJ), with many reporters there experiencing threats, harassment, and assault. According to the CPJ research, threats against Pakistani journalists have come from a variety of sources, including militant organizations, political parties, and governmental institutions. Several high-profile instances of journalists being assaulted or killed for their work have occurred in recent years, notably the 2018 murder of writer Jamal Khashoggi. In the 2021 World Press Freedom Index, Pakistan was placed 145th out of 180 nations, according to a Reporters without Borders report. The report points out that while Pakistan has a broad media landscape with many sources and platforms, the government nevertheless maintains a strong degree of control over the media. The report also emphasizes the dangers to journalists working in the nation, such as intimidation, censorship, and assault. Despite these difficulties, there have recently been some encouraging developments, such as the introduction of new media channels and improved internet access. According to a survey by the Friedrich Ebert Stiftung, Pakistan now has more options for citizen journalism and media freedom thanks to the growth of social media and digital platforms.

#### 2. Literature review

Siraj and Hussain (2017) reviewed the freedom of the press in Pakistan. The study's primary thesis supported the idea that Pakistani journalists lack the freedom to choose the news and information they want to report on. The choice of which news to broadcast depends on how sensitive it is, and editorial management makes that judgment. Gatekeepers work for and serve those in power since Pakistan's modern media is reliant on advertising money. Therefore, political, social, economic, and concentrated ownership are constraints on journalistic sovereignty.

Najam Sethi, March 2021 the authorities disregarded Imran Khan's illegal behavior because, according to the other columnist, the system was on his side. The columnist goes so far as to assert that the army manipulated the 2013 election in his favor and that the establishment even planned for his sit-in during the election. When the agenda wasn't finished, by designating him as a revolutionary leader at the time, the establishment dispatched him to Islamabad to stage sit-ins. to

overthrow the Nawaz government. In 2014 and 2016, attacks occurred in Sharif, Islamabad. However, he failed because of the people.

According to a Reporters without Borders report (The News, 2021), the government financially restricts critical media. Homes and attacks on bloggers and journalists were frequent. (The News, 2021) During the Khan presidency, Regulators of social media and electronic communications have become obedient to governmental directives.

Mazhar Barlas, March 2021, portrays Imran Khan favorably and shows him as a person who might have lived a better and more pleasant life. The columnist declares that he chose politics not for popularity or monetary gain, as he already had them, but rather to improve his country and its people after listing all the other excellent possibilities open to him in life to cover his expenses. He could have lived a life of luxury in England as a cricket analyst or as the chancellor of Bradford University. In Pakistan, he also had the choice of being Nobody would have minded him if he had selected any of these. He was recognized as a national hero who was loved and respected by the entire country. The chairman of the PCB, the head coach of the Pakistan cricket team, or a social worker (Dawn, 2020)

Jang News Imran Khan is portrayed in a primarily negative light. He is regarded as an establishment-backed politician who, despite having been active in politics for many years, is still looking for ways to gain power. It was said that his sit-ins were unlawful and that he was self-centered and egotistical. Furthermore, it was stated that Imran Khan may seize Mr. Sharif and gain power through the Panama issue. Between 2017 and 2021, more than 4,000 journalists were laid off, claims the Federal Union of Journalists. Hameleers, 2018 The Imran Khan administration employed hundreds of people on its massive social media team to promote its positions and refute dissenting opinions. The majority of the journalists reported that online trolls had attacked them. Several journalists asserted that edited images of them and their family members were distributed to publicly humiliate them.

#### 3. Problem Statement:

Pakistan's media environment has always been filled with difficulties, including censorship, threats against journalists, and historical government control. In spite of recent improvements like expanded internet connectivity and new media outlets, the nation is ranked poorly in the World Press Freedom Index. The Committee to Protect Journalists draws attention to ongoing dangers that impede the media's ability to serve as a watchdog for democracy and come from a variety of sources. The study also reveals complicated dynamics in the connection between politics and media during Imran Khan's administration, when journalists faced restrictions on their independence and the rise of social media as a double-edged sword. To promote a more open and democratic society, the main issue is how to deal with Pakistan's media's safety, independence, and changing dynamics.

It was important that the informants had experience in their respective fields because of this. The researcher conducted interviews before transcribing the information. Every interview started in Urdu and was later translated into English. The final transcripts were printed once the research questions and supplementary questions' key arguments had been determined by consensus.

#### Interview No. 01: Gareeda Faroogi

The period of Imran Khan, and the dynamics in the period of Imran Khan are altogether different. His party is very active on social media, and he has been driving a large part of his media power through social media. During the tenure of Imran Khan, that last window was also closed. It was very suffocating; you could not speak on any channel. In any case, the voice was completely strangled during the tenure of Imran Khan Imran Khan's era, the state operators were much stricter

#### Interview No. 03: Matiullah Jan

The steps in Imran government taken for media was very deplorable(shameful) kidnapping, torture ban on journalists and media channels arrests, raids, joblessness was observed in Imran Khan era. He cannot take any good steps for media if anything was discussed for safety of journalist it was just talks nothing else. He used social media as Hitler use media as propaganda tool. He survives just because of social media main stream media has no worth in Imran Khan point of view but its fact social media's popularity cannot survive long.

## Interview No. 04: Ather Kazmi

The results, however, imply that the mainstream media encountered hitherto unseen difficulties, including charges of prejudice, a lack of openness, and retaliatory actions against anti-government publications. The story shows how Imran Khan's administration deliberately suppressed dissenting opinions in traditional media while using social media to further its cause. The selective control and manipulation of information flow is clarified by the gatekeeping idea. Social media offered a channel for more direct connection, even though there were worries about false information, while established media struggled under constraints. The contradictory positions Imran Khan has taken on media freedom both endorsing its ideals and denouncing alleged biases highlight the intricate relationship between politics and journalism. Particular concern is the effect of Imran Khan's government on jobs for journalists. A wider financial difficulty for media professionals is suggested by reports of job losses and pay reductions that affected up to 500 journalists under his administration. Because of this financial susceptibility, it is important to investigate long-term media funding strategies that maintain editorial freedom while also ensuring profitability. Given Pakistan's placement in the World Press Freedom Index, the findings also address how the press is perceived internationally. There are still issues, such as political influence and journalistic threats, even though media variety and accessibility through digital platforms have improved. One useful way to find effective solutions for striking a balance between media freedom and governmental control would be to compare and contrast these difficulties with those in other nations.

The information presents a complex picture of Imran Khan's handling of the media throughout his presidency. On the one hand, his skillful use of social media as a potent instrument for political influence and communication is acknowledged. Khan was able to get beyond the limitations of traditional media because to his planned engagement and powerful social media staff. 6. Conclusion

Researchers examined the situation of media freedom in Pakistan from August 2018 to April 2022, during the populist administration of Imran Khan. Semi-structured interviews with senior journalists from illustrious newspapers and TV networks around the nation were done for this reason. The majority of journalists concurred that the Imran Khan administration severely curtailed media freedom in the nation. The journalists noted that there were primarily two methods used to impede the free flow of information: first, by physically attacking, kidnapping, intimidating, and accusing journalists of sedition; and second, by strangling the media outlets' economies by denying them their fair share of advertising. The PTI government's anti-media actions were unprecedented. Senior journalists reported that in the past. The Imran Khan era, the opposition has no right to speak against him openly. Imran Khan cannot do anything good for journalists; even during his regime. Imran Khan used social media as effectively as Hitler used the media as a propaganda tool. Imran Khan has been critical of the media in Pakistan, accusing it of being biased, sensationalist, and lacking in transparency and accountability.
